

TERMS AND CONDITIONS

LIONEX TOKEN (LNXT) Ecosystem

Effective Date: 10 August

Introduction

Welcome to LIONEX (accessible via www.lionextoken.io). By accessing our website, creating an account, or participating in the LIONEX staking and referral ecosystem, you expressly agree to be bound by these Terms and Conditions ("Terms"). If you do not agree to all of these Terms, you are strictly prohibited from using the platform and must discontinue use immediately.

1. Nature of the Platform

LIONEX is an unregistered, decentralized, community-driven cryptocurrency project operating on the Binance Smart Chain (BEP-20). We are **not** a registered financial institution, investment firm, or government-regulated entity. Participation in LIONEX is strictly voluntary and should not be construed as a traditional financial investment. The platform operates as a software utility that distributes LNXT tokens based on predefined community networking and staking metrics.

2. Account Rules and KYC Verification

- **Age Requirement:** You must be at least 18 years old to participate.
- **Single Account Policy:** Users are strictly limited to **one (1) account per individual**. Creating multiple accounts (stacking) to manipulate the genealogy tree or generate artificial referral bonuses is expressly prohibited. (Note: Platform administration reserves the right to hold multiple operational accounts).
- **Future KYC Rights:** While LIONEX does not currently require identity verification upon registration, we reserve the right to mandate Know Your Customer (KYC) documentation (such as government-issued ID) at any time to verify account ownership and enforce the single-account policy. Failure to comply with KYC requests will result in account suspension and forfeiture of funds.

3. Prohibited Conduct and Non-Compete Clause

To protect the integrity of the LIONEX community, the following actions are strictly prohibited:

- **Competitor Participation:** Users are strictly prohibited from actively promoting, recruiting for, or participating in competing cryptocurrency ROI or MLM platforms. If administration

discovers you are diverting LIONEX members to a competitor, your LIONEX account will be immediately banned.

- **False Marketing:** When promoting LIONEX, users must not make false income guarantees or present the platform as a “guaranteed safe investment.” Affiliates must clearly state that LIONEX is a community-based crypto project and that all participation carries inherent risk.
- **System Manipulation:** Any attempt to hack, exploit, or artificially manipulate the virtual staking ledger or withdrawal system will result in permanent expulsion.

Penalty for Violation: Any violation of these rules will result in an immediate, permanent ban. Banned users **forfeit all access to their accounts, staked funds, pending ROIs, and networking bonuses.**

4. Financial Mechanics and Dynamic Adjustments

As outlined in our Refunds & Cancellations Policy, all deposits are final and non-refundable. Furthermore, you acknowledge that LIONEX is a dynamic system:

- Staking packages (Min \$50 - Max \$10,000) cap at 200% earning or 250 days.
- Base ROI (currently 0.5%) and all supplementary bonuses (Level, Fast Track, Holding) are promotional and can be lowered (e.g., to 0.1%) or removed entirely at the administration’s sole discretion.
- Withdrawal fees are subject to change without prior notice, up to a maximum of 50% plus a \$5 flat fee per transaction.

5. System Uptime, Modifications, and Shutdowns

LIONEX is provided on an “AS IS” and “AS AVAILABLE” basis. The administration reserves the absolute right to:

- Pause or disable withdrawals temporarily for system maintenance, security audits, or network congestion.
- Modify, suspend, or permanently terminate the platform, its servers, or its smart contracts at any time.

You explicitly agree that LIONEX, its creators, and its administrators hold **absolutely zero liability** for any loss of funds, tokens, or potential profits resulting from platform downtime, suspension, hacking incidents, or a complete operational shutdown.

6. Taxes

You are solely responsible for determining what, if any, taxes apply to the LNXT tokens you earn or withdraw through the platform. LIONEX does not withhold, collect, report, or remit any taxes to any government or regulatory body on your behalf.

7. Limitation of Liability and Legal Waiver

PARTICIPATION IS ENTIRELY AT YOUR OWN RISK. Cryptocurrency is highly volatile, and participating in staking and referral ecosystems carries a high risk of total loss.

By using LIONEX, you expressly waive any and all rights to initiate, participate in, or join any lawsuit, class-action lawsuit, legal dispute, or arbitration against LIONEX, its founders, developers, or administrative team. In the event of a platform failure, loss of token value, lack of external liquidity, or administrative termination of your account, you agree that you have no legal recourse and hold LIONEX entirely harmless.

8. Changes to Terms

We reserve the right to amend these Terms and Conditions at any time. Continued use of the platform after changes have been posted constitutes your binding acceptance of the updated Terms.
